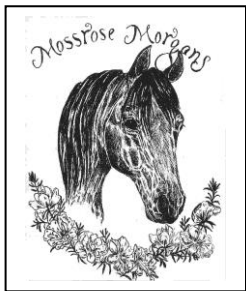

This contract is for the 2021 breeding season, made and entered into by and between the stallion lessee:

River Falls, WI 54022 and the mare owner:

Breeding Fee:

This contract covers the mare: _____
AMHA # _____ being exposed to the stallion, *Whippoorwill Aristocrat* AMHA #145068, whose 2021 service fee is \$1,000. A \$200. non-refundable booking fee is to be paid with this contract. The balance of the stud fee, \$800. is due before the mare leaves the stallion lessee's farm. For AI mares, the balance of the stud fee is due when mare is confirmed pregnant by ultrasound within 30 days of final breeding. If the mare does not conceive on the first 2 heat cycles, the mare must be cultured and be negative for infection and proof of same be provided to the stallion lessee before further breeding be done or shipments sent. The above mare will not be served more than four estrous cycles during the breeding season.

AI Collections:

AI collections REQUIRE 24 hour notice. Close communication between mare's veterinarian and stallion lessee will be maintained throughout the breeding cycle, collection and insemination of your mare. A deposit of \$400. for collection and transport is to be paid with this contract or before the first shipment of fresh cooled semen. Actual costs will be computed & an invoice or refund will be sent to mare owner after collection & shipment.

Live Foal Guarantee:

The stallion lessee guarantees a live foal from the breeding. A live foal is defined as that which will stand and nurse. If the resulting does not stand and nurse, a statement describing said occurrence signed by your veterinarian must be furnished to the stallion lessee. In such case, mare owner is guaranteed a return privilege to a mare, which has been approved and accepted for breeding by Mossrose Morgans. Should the foal die as a result of injury or neglect, the stallion lessee is under no further obligation in that matter.

Other Expense:

Mare owner agrees to pay board expense at the rate of \$7.00 per day for an open mare or \$10.00 per day for a mare with foal. Mare must have a negative coggins. Mare owner will pay farrier and veterinary expenses, including drugs, supplies, medication or tests, as they are deemed necessary by Mossrose Morgans. Stallion Service Contract & Stallion Report will be signed when all charges are paid in full.

Contract Nullification:

Should the above named stallion die or become unfit for service or should the above mare die before being served (unless both parties agree to a substitute mare) this contract shall become null and void and the booking fee shall be refunded to the mare owner, except for any previously incurred transporting or mare care expenses.

Waiver of Liability:

It is understood that the stallion lessee, Mossrose Morgans, managers, employees, or agents shall exercise good judgment in caring for the mare and foal; but shall not be liable for any injury, disability, or death suffered by the mare or foal from any cause whatsoever while on the premises. I, the mare owner, have read and specifically assent to the foregoing and waive any and all claims resulting from any such injury, disability, or death.
